



The Green Bay Area Skate Organization (GBASO) is located in Ashwaubenon. The atmosphere at GBASO is welcoming and supportive of all types of learning styles. Not only will your child develop coordination and balance, but they will also build confidence, improve their concentration, develop perseverance, and improve their self-esteem.

GBASO offers progression sessions based on skill level. If your child is new to skateboarding, coaches will teach basic skills for safe riding. If your child is experienced, they will be with other skateboarders at a similar level and coached how to advance on their boards.

Progression sessions are \$25, with a discounted rate of \$15 per session for Pioneer Elementary students. The \$15 includes rental equipment (skateboard, helmet, pads) and instruction.
